## AGE CATEGORIES

- 11 years and younger
- 12 -15 years
- 16 years and older

To be placed in the age category, the competitor's age as of December 31st 2026, is decisive. For team categorization, the age of the oldest competitor in the team is decisive. Different age categories cannot be combined.

## GENDER CATEGORIES

- Single events: men, women
- Team events: men, women, mixed

There must be at least 4 competitors/teams in one gender category.

In case of fewer competitors/teams, the categories are merged according to IJRU rules, or they are evaluated using the rule called cross-ranking.

## ENTRY FEE

- For one registered competitor:
- 1-3 disciplines - 900 CZK (discounted entry fee for Czech Jump Rope members 600 CZK)
- 4 or more disciplines - 1200 CZK (discounted entry fee for Czech Jump Rope members 900 CZK)

The entry fee is to be paid by bank transfer to account number 2800576736/2010 (IBAN: CZ6920100000002800576736, BIC/SWIFT: FIOBCZPPXXX) based on the issued invoice, collectively for the entire team/club, no later than the invoice due date. Include the team name + entry fee in the payment note.

To qualify for the discounted price, the competitor must be a member of Czech Jump Rope z.s. at the time of registration, meaning they must have an approved membership and membership contributions must be credited to the Czech Jump Rope z.s. account.

In case of registering to Czech Jump Rope z.s. before submitting the application for a points scored competition by Czech Jump Rope, please allow for a processing period of 5 business days.

In case of a registered competitor's non-participation, the paid entry fee is non-refundable. If a participant does not compete in some of the registered disciplines, the paid entry fee is not retroactively reduced.

## APPLICATIONS

Registration is open at <https://registration.ijru.sport/> since March 21st, 2026 till April 12th, 2026. To log in to the IJRU system, you must have an active IJRU account. ## MUSIC

All freestyle disciplines are accompanied by music. Musical accompaniment for freestyle disciplines must be uploaded to the IJRU system. The music track must be labeled with the discipline for which it is intended (SRIF, SRTF, SRPF, DDSR, DDPF, WHPF, SCTU), the name of the team/club, and the surnames of all jumpers.

For example: SRPF/Rebels/NovotnaSvoboda.mp3.

The length of the music track can be up to 75 seconds. (for SCTU maximum of 360 seconds).

The time schedule will be clarified 2-3 days before the competition according to the number of competitors.

## JUDGES

**SPEED** - Each team/club is required to register one judge for Speed disciplines for every 12 initiated entries in speed disciplines. Speed judges must have at least IJRU Judge Level 2 certification (<https://ijru.sport/rules/judge-training>) v4.2.0. Each Speed judge must have their own clicker or mobile application. A speed judge cannot compete in any speed discipline at the same time.

**FREESTYLE** - Each team/club is required to register one judge for Freestyle disciplines for every 9 initiated entries in freestyle disciplines. Freestyle judges must have Level 2 certification, i.e., completed judge training conducted by a certified IJRU trainer v4.2.0. For evaluating freestyle disciplines, judges will be allowed to use officially provided devices by Czech Jump Rope z.s. with the Rope Score application. A freestyle judge cannot compete in any freestyle discipline at the same time, an exception is possible only after prior personal agreement with the organizer [olga.kepkova@seznam.cz](mailto:olga.kepkova@seznam.cz).

Evaluation of FS with personal devices will be allowed only if the judge has the latest valid version of the IJRU application installed.

A **competition entry** is understood to mean the participation of one competitor in a single discipline or a team in a team discipline (e.g. the participation of a competitor in the Single Rope Speed Sprint discipline is 1 entry, as well as the participation of 4 competitors in the Single Rope Speed Relay discipline, which is also counted as 1 entry).

In the event of non-participation of registered competitors, the required number of judges for the given team is not retroactively reduced and judges cannot be deregistered.

The minimum age of judges is 15 years. The competition organizer may grant an exception.

### CERTIFICATION OF JUDGES

No later than 12.4.2026, it is necessary to send valid IJRU certificates of all registered SPEED and FS judges to the email address [olga.kepkova@seznam.cz](mailto:olga.kepkova@seznam.cz). Without sending valid certificates by the specified date, the judge will not be considered properly registered.

### INSUFFICIENT NUMBER OF JUDGES:

A fee of 1200 CZK is charged for each missing freestyle judge.  
A fee of 1200 CZK is charged for each missing speed judge.

# GENERAL TERMS AND CONDITIONS OF THE COMPETITION

1. The competition is conducted according to the current rules of IJRU unless stated otherwise in these regulations. Submission of the application is considered as a confirmation that athletes, coaches, referees, and team accompaniment have familiarized themselves with all current rules and agree to observe them.
2. All the athletes and referees must arrive at the competition venue at least 20 minutes before its start. If they fail to do so within this period, the team may be disqualified.
3. Any questions regarding the rules and the course of the competition should be aimed at the director of the competition and should be raised before the start of the competition.
4. It is prohibited to soil the racing area (e.g., with glitter, crushed magnesium...). If this happens, the head coach of the particular team is responsible for restoring the area to its original condition before the entry of another competitor. Failure to do so will be considered as an unfair sports behavior.
5. All competition participants undertake to maintain fair play throughout the competition. The head coach of each team is responsible for observing the rules and appropriate behavior of all team members. In case of rule violations, unsportsmanlike, or inappropriate behavior, the team may be disqualified from the competition and automatically lose the right to be awarded.
6. By participating in the competition, every athlete and coach agrees that decisions made by referees are final and are not a subject to later review. Each athlete acknowledges the necessity for referees to make prompt and fair decisions in the competition and waives any legal or administrative review of such decisions.
7. By entering the competition, athletes, coaches, referees, and team accompaniment give their consent to the organizer to use media containing their voice and/or appearance. This consent also applies to photographs, sound recordings, and video recordings. The Organizer is entitled to edit, modify, copy, display, distribute, and publish these recordings in print, video, audio recordings, and web content for any legal purpose without payment or any other compensation. The described material becomes the property of the organizer and may be used for advertising, commercial, promotional, or educational purposes. Competition participants waive the right to control or approve the finished product, including written or electronic copies, depicting the appearance and/or voice of the participants.
8. Participants take into account that data (name, gender, year of birth, etc.) collected during the registration and/or during the competition may be used as results and statistics and also for a public communication regarding the competition. However, this collected data is protected in accordance with the requirements of the General Data Protection Regulation (GDPR).
9. By registering for the competition, participants acknowledge that they participate at their own risk and release the Czech Jump Rope,

z.s. (VAT: 07647476) and the REBELS O.K. ROPE SKIPPING ŘEVNICE, z.s. (VAT: 02445824) and all persons associated with the organization of the competition from any liability for damage, injury to health or other claims arising in connection with participation in the competition, regardless of whether they arose from negligence or other causes. Participants further agree to provide necessary first aid or medical care in the event of injury or sudden illness during the competition and assume all possible financial responsibility associated with this care.

10. By submitting the application, the participants confirm that they have undergone a sports medical examination confirming that their health condition does not limit or exclude participation in the competition. The medical confirmation must not be older than one year, and all athletes must have it with them during the competition and present it for inspection upon the request of the Organizer's authorized representative. If an athlete does not present a valid medical confirmation, they will not be allowed to participate in the competition in accordance with the current Decree on Health Fitness for Physical Education and Sport issued by the Ministry of Health of the Czech Republic under No. 391/2013 Coll.

11. By submitting the application, the participants confirm that supervision in full scope is provided for minors throughout the entire duration of the competition by the appointed coach of the club/school/team. If an underage competitor competes individually without a club/ school/team, they must have the full-time supervision of an adult throughout the entire duration of the competition.

12. The organizer is not responsible for the loss of personal belongings.

13. During the competition, it is prohibited to move around the competition area except for organizers, referees and competitors currently competing.

14. During individual disciplines, jumping and warming up on the competition area is prohibited. A separate part of the area is designated for this purpose. Jumping on the competition area is only allowed before the start of the competition and during breaks between disciplines unless the organizer specifies otherwise.

15. Each competitor is obliged to accept a prize personally. If a competitor does not attend the results announcement and does not accept the prize, the prize will not be awarded.

The organizer reserves the right to change the regulations if necessary.

16. All participants, coaches, referees, accompanying persons, and event visitors are required to comply with the generally binding ordinance of the city of Černošice on public order protection, traffic regulations, and to behave in a manner that does not disrupt public order or endanger the safety of persons and property. Each participant bears personal responsibility for adhering to these rules. The event organizer is not responsible for offenses or other unlawful conduct by individuals.

## ACCOMMODATION

The organizer does not provide accommodation. Sleeping in the gym is not possible.
